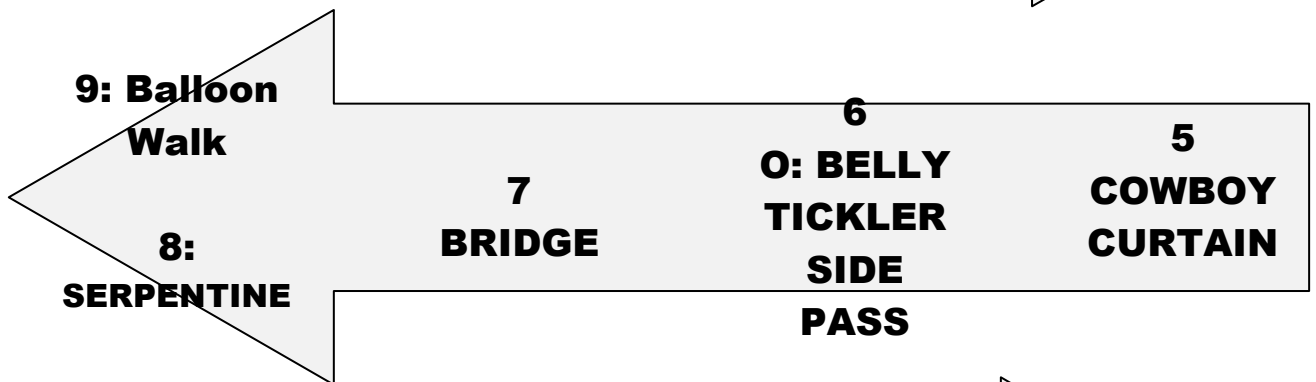
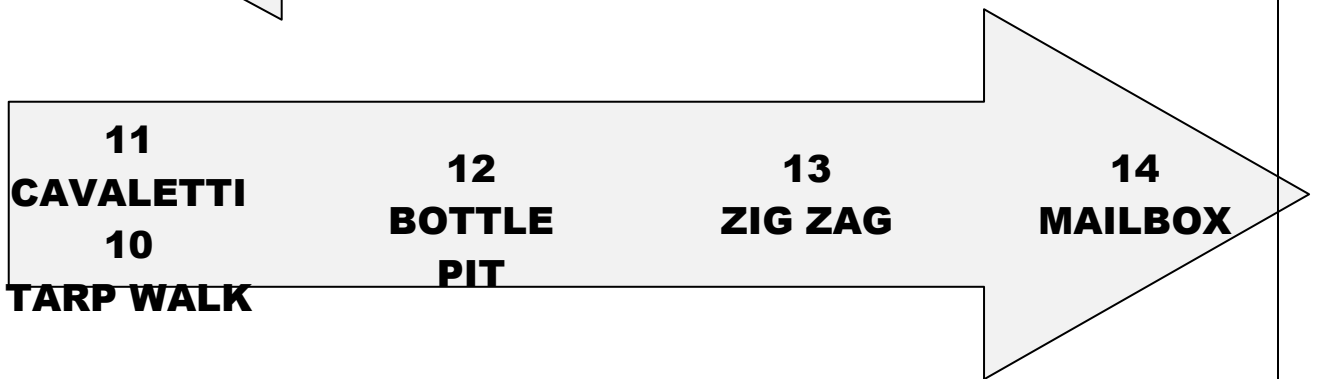
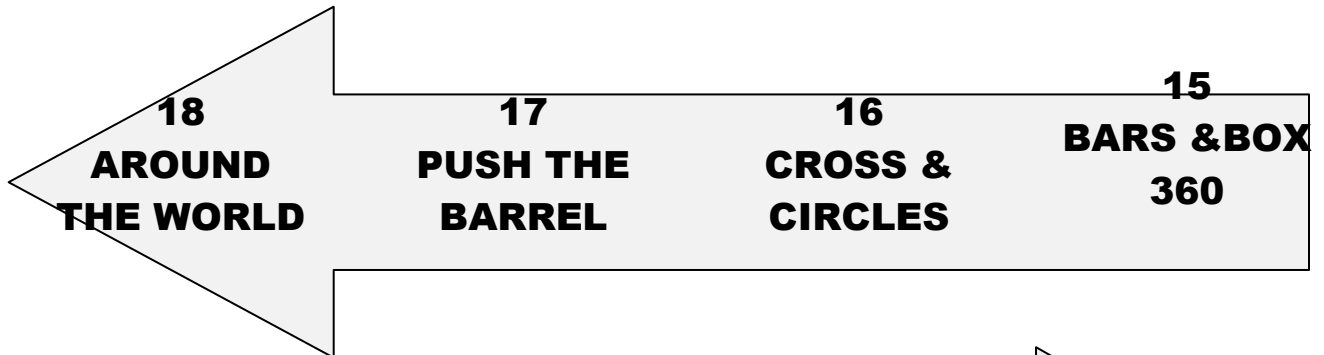

## Instructions for Obstacles

	Obstacle	Novice	Open
1	Rope Gate	Open the gate with right hand and pass through, close the gate	Reverse through the gate with the rope in your right hand
2	First Tee	Pick up golf ball from the barrel and drop it into the cone	
3	Tire Maze	Random tires, with path. Avoid the tires.	Plus some distractions
4	Dismount/ Mount	Dismount at cone near the picnic table. Pick up the right front. Lead to picnic table and mount up	Plus - offside mount. Walk back to the cone, stop and drop reins on neck for a count of 10. (Judge to count).
5	Cowboy Curtain	Walk through the curtain of streamers	
6	Side Pass Belly Tickler	Side pass over obstacle one direction	Side pass over obstacle both directions
7	Bridge	Walk over the wooden platform	Front hooves on the platform side pass 180 degrees then cross
8	Serpentine	Weave through cones at jog/trot halt at flag. Count to 3 out loud	
9	Hula Hoop	Front feet in, turn half circle	Get the hoop Front feet in turn half circle Back feet in turn half circle
10	Tarp Walk	Walk calmly over the tarp	
11	Passing Stranger	Wait for the nutter with all the gear to pass by	
12	Bottle pit	Walk across the short side of the bottle pit	Walk the long side and pause for 5 seconds in the center
13	Zig zag	Walk into the zig zag and <b>reverse</b> out	<b>Reverse only</b>
14	Mail box	Open, retrieve package, replace and close mailbox	Open, retrieve package, shake it, replace and close mailbox
15	SPIDER!	Walk around the spider	Then face the eyes & step over it
16	Cross & Circles	Walk over each pole at blue mark, completing a <b>large circle</b> . Next, walk a <b>small circle</b> over the end of two poles	
17	Push the Barrel	Push a barrel with horse's nose or feet from one end of the rails to the other	
18	Around the world	Pick up the handle and walk around the barrel. Return to rest position	Do it in both directions
19	Drag	n/a	Drag heavy load behind horse until horse passes first cone. Turn horse on front legs and back up and pull load until they pass the 2nd cone
